


#### Our Region

NLCMHA is part of the Pre-Paid Inpatient Health Plan (PIHP) called the Northern Michigan Regional Entity (NMRE).

The NMRE includes 5 CMHs and covers 21 counties.

There are 10 PIHPs in Michigan.





#### **NLCMHA** serves:

- Adults with serious mental illness
- Persons with intellectual and developmental disabilities (I/DD)
- Children with serious emotional disturbance
- Persons with cooccurring substance use disorders

### Northern Health Care Management

NHCM, a division of NLCMHA, is a MI-CHOICE Waiver program which operates in 10 northern Michigan Counties.



NHCM serves older adults and persons with disabilities who wish to remain living at home or in a community setting, instead of in a nursing home.

### Northern Health Care Management

Eligible adults who meet income and asset criteria can receive Medicaid-covered services like those provided by nursing homes in their own home or

other residential setting.

### Integrated Health Care

At NLCMHA we are changing our approach and providing care in a new way.

We recognize the emotional effects of physical diseases as well as the effects of trauma on both physical and emotional health and healing.

We help people with their mental illness, IDD, and/or substance use disorder at the same time we help them manage their chronic illnesses and learn about prevention, health and wellness.

#### What we do...

We cultivate hope. The hope that someone has when taking their first small step toward recovering from a mental illness.

### **Accessing Services**

When you contact us you can expect prompt answers to your questions about our services and eligibility requirements.

Priority is given to individuals with the most severe forms of serious mental illness, serious emotional disturbance, and intellectual/developmental disability.

### **Accessing Services**

Three areas affect decisions about your treatment: 1) Clinical condition, 2) Therapeutic appropriateness, and 3) Medical necessity.

If you do not meet eligibility requirements as outlined in our contracts with the Michigan Department of Health and Human Services (MDHHS), we will assist you with referral to other service providers.

### What is the access process?

A qualified Mental Health Professional will complete a telephone screening when you call to request services and, if you qualify, will arrange a face-to-face interview at a time and location convenient to you.

After your confidential interview, we will review your concerns and findings with you and help you decide on an appropriate course of care.

### Then what happens?

If you qualify and are interested in ongoing behavioral health services, we will link you to the programs and/or services best suited to your needs. In most cases we will arrange your first appointment within 14 days.

We will also answer questions about your benefits and costs for services. We coordinate care with your health care provider and your health plan to make sure the services you receive are efficient and effective.

# What if I don't qualify for services?

If you do not meet eligibility requirements for <u>ongoing</u> <u>services</u> as outlined in our contracts with MDHHS, we will explain why and we will assist you with referral to other service providers.

### What if it is an emergency?

Emergency mental health services are always available 24/7 for anyone who is experiencing a mental health crisis. You do not need to meet <u>any</u> eligibility requirements to be served in an emergency.

# Ask for F.A.S.T. if the crisis involves a young person

Ask for F.A.S.T. for an extra layer of care for families with children age 0 to 20 in crisis. Follow up for 90 days may be provided. Our FAST team will come to you if needed.

- School safety needs




#### Increased costs

### Funding system has removed flexibility and decreased local control

Only 4% of the funding provided to the CMH system is available to serve Michiganders without Medicaid who need mental health services.

NLCMHA provides high quality, comprehensive behavioral healthcare to over 5,600 persons in our six NLCMHA counties and over 400 people in our ten NHCM counties.

We also provide 2000+ face-to-face crisis interventions each year and answer 7,200 crisis calls.

As we leverage the federal, state and local investments necessary to bring healthcare to our most vulnerable citizens, we also generate economic gains within the communities served.
