5. CHIEF EXECUTIVE OFFICER'S REPORT:

Karl reported on the upcoming changes initiated by MDHHS. On the behavioral health side, they are promoting an integrated plan. They are looking to eliminate PIHPs and implement Integrated Specialty Plans with possible statewide and regional options that people could enroll in. We were told that we would be getting additional capitation payments, but something went wrong with the Habilitation Supports Waiver (HSW) payments. The state has said that they will allow us to expand the Health Home Pilot into all 21 counties by 10/1/2020. Last year the state did an analysis of our Health Home pilot in Manistee and Grand Traverse counties and found that we were saving \$366.00 per person per month. Mary commented that the Christmas celebration was very nice. Pam noted that there is still a shift in attitude that needs to happen in the public health system, especially when it comes to those developing the models.

6. NORTHERN MICHIGAN REGIONAL ENTITY REPORT:

There were no minutes provided for the meeting.

Randy reported that the primary focus of the NMRE this month was 298.2 – The health plan association has been pushing for the public system to go private. In the State of Michigan there are over 600 integrated care projects. Randy does not believe that the system is broken. The State Association took the stand to neither support nor combat the Governor's proposal and many members of the NMRE spoke against this. Randy also asserted that the opioid crisis does not discriminate and shared a story about the dangers that he has seen. He wants to help break stigma and wants to assure those that they are not alone.
