**7. CHIEF EXECUTIVE OFFICER’S REPORT:**

Karl referenced the MDHHS Proposed System Redesign included with his report. He identified that we had an excellent turnout at the Virtual Public Forum held on February 6 at each of our office locations. On Friday, February 21 there will be a Public Forum held at Kirtland Community College from 2:30 to 4:00 pm. Staff will be bringing people we serve to the forum. Karl has distributed the handouts at his presentations at the County Commission meetings. We had discussed at our Nominating Leadership Development Committee visiting our counties to educate our commissioners regarding the redesign. Leelanau County completed a resolution and will be sending to the Governor, Michigan Association of Counties and Senators and Representatives from our local areas. Karl also sent an email with attachments to Senators and Representatives to remind them of the Public Forum on February 21 to raise awareness.

The actions of the NMRE Operations Committee demonstrate that we have a strong region and we are ready to expand the Behavioral Health Home across all 21 counties. We will be inquiring to see if there are potential partners for the Specialty Integrated Plans (SIP) that MDHHS is proposing. The CMHAM is trying not to be so confrontational and to be engaged at the ground level with MDHHS.

Northern Lakes CMHA will be presented an award at the State Clubhouse Annual Employment Celebration for being the employer that they wanted to honor this year. We have employed members of Traverse House as greeters and parking lot monitors and has been a meaningful effort. Karl will be there to receive the award.

Karl and Board Members who attended the presentation to the Grand Traverse County Commission provided their perspectives on the February 19 meeting related to services and the concerns raised at the January 22 meeting about the county contribution level. A Power Point presentation was provided as well as additional information from the Ad Hoc Committee that looked into county contributions in 2011. Karl shared background information and identified that the county contributions were fixed in 1997. A consumer shared his story about services he has received from NLCMHA and who now lives in the community.
